Tel.: +36-1-463-3521 www.epitesz.bme.hu Based on the authorisation granted in BME Code of Studies (hereinafter: CoS) Section 88 (8), the BME has adopted the Rector's Instruction No. 2/2024 (II. 19.) on its modification, I hereby determine the timetable of the Faculty of Architecture of the BME (hereinafter referred to as the Faculty) for the academic year 2024/2025 with the consent of the Student Committee¹ as follows:

1. § Scope of the Instruction

- 1) The material scope of this instruction covers all basic, undergraduate and master course works within the faculty.
- 2) The personal scope of this instruction applies to:
 - a) to any person who is a student of the University and is enrolled in a bachelor's, master's or master's degree programme offered by the Faculty,
 - b) to all persons who are not students of the University and who have obtained a diploma in architecture in their bachelor's, master's and diploma courses, for the duration of their final examination, and who are registered for the final examination after the termination of their student status, in this case only for the purposes of the provisions relating to the final examination,
 - (c) all departments involved in the teaching or organisation of education, all teachers, researchers and lecturers, and all persons with teaching or organisational duties.

- b) Global exams which are prerequisites for subjects must be arranged during the first week of study period.
- c) The educational unit responsible for the subject may announce an early examination for students who are eligible to take the examination, during the study period and late completion period, which must be published in the Study Administration System (SAS) at least three weeks prior to the exam date.¹⁰

- e) There are no compulsory lessons during Preliminary Design and Draughting Weeks. Although these same classes might be made available for consultancy purposes on a non-mandatory basis.
- f) Preliminary Design and Draughting Weeks are not for the purpose of summative performance assessments, or their repetition, correction, or replacement.
- g) During the Preliminary Design and Draughting Weeks, formative performance assessments (submission of drawing assignments) may only be held in accordance with the performance assessment plan approved by the Study Committee of the Faculty (hereinafter referred to as 'FSC').
